



The number of the criminal cases receiving and closed in the latest six years



The Number of Receiving and Closing for the Investigation Cases in the latest six years






The cases of final and binding judgment in conviction in latest six years (Imprisonment)










The percentage of deferred prosecution in the drug-using concluded






Situation of corruption and malfeasance cases investigation concluded






