
I. The Meaning and Key Concepts

In the context of law and justice, "rehabilitation" conventionally refers to enabling those released from confinement in a correctional facility return and readjust to the society, with methods involving therapy, education, and training, to prevent recidivism after they have returned to society. In contrast with the institutional methods used in prisons, rehabilitation is a "de-institutionalizing" correctional process that mainly encompasses parole and rehabilitative protection. This conventional view centers primarily on the prevention of recidivism.

Judicial protection, on the other hand, refers to the protections offered by the judicial system to protect ordinary citizens. Consequently, various measures are resorted to during the pre-investigation stage, prosecutorial investigation, trial, execution of penalty, parole and probation. After the inplementation of Crime Victim Protection Act, attentions have been paid to crime victims.¹

Judicial protection in the ROC is centered on the three-tier of crime prevention. The first tier is to prevent criminal acts from occurring in the first

place, by encouraging respect of the law among ordinary citizens, so that the will to commit criminal offenses does not arise. The second tier is to deter crime before it is committed, targeting individuals who are potentially in danger of or on the verge of committing offenses, so that they are unable to or unwilling to commit crimes. The third tier is to prevent recidivism, by monitoring offenders and pursuing rehabilitative measures, so that they reintegrate into society without recidivism. The following is a detailed breakdown of measures incorporated in each tier.


First tier: criminal studies, promoting legal knowledge and crime prevention,

legal services, judiciary assistance.

Second tier: devoting increased attention to vulnerable students, legal assistance, crime victims protection and assistance, deferred prosecution.

Third tier: counseling vulnerable students and juvenile offenders, in-prison counseling, probation and rehabilitation services that aim to prevent repeat offenses after release from incarceration.

Building upon the three focal points set by the Ministry of Justice, the missions, intended targets, and scope of administration are as follows:





A.Parties affected by crime, segmented according to the type of crime and relevant needs into the rehabilitated and their families, and crime victims and their families

Probation cases under the jurisdiction of the Taipei District Prosecutors Office are supervised by one acting Head Prosecutor and three prosecutors; judicial administration is supervised by the Chief Probation officer, with probation officers working in separate task forces as follows: sexual assault, community service and socail labor services, honorary probation officers, substance abuse, counseling, and probation administration. In principle, task forces rotate half of their members every two years, with the members of each task force fully rotating every four years. Task forces coordinate work between each other to facilitate inter-task force missions.

The above diagram shows that the Taipei District Prosecutors Office assigns cases according to the circumstances of the crime and the subject involved. In addition, probation officers regularly review their situations and methods, and evaluate the risk of recidivism in each of their subjects, as well as the danger of any recidivated possibility; for subjects in mid to high risk of recidivism, monitoring will be increased. Furthermore, officers hold regular life education courses, provide assistance through religious organizations, and offer employment assistance and group counseling, using both strict and soft measures to help rehabilitate their subjects.

B.Crime prevention and public care, covering activities to promote awareness and care for the disadvantaged

This involves efforts to promote legal education, crime prevention, and awareness of how deferred prosecution fines are used, and are geared toward members of the community and disadvantaged individuals. The Taipei District Prosecutors Office annually administrates public awareness projects targeting drug abuse and vote buying, and holds crime prevention awareness programs for summer vacation in the school year. In addition, the Office cooperates with schools in its jurisdiction in holding community life camps for vulnerable students, offering resources to schools to assist in educating delinquent students. All of these events and activities have guidance and counseling components to ensure the key missions of crime prevention and avoidance.

In addition to supplementing the public treasury, fines accumulated in deferred prosecutions are also offered to organizations for public welfare or charity purposes upon approval of application for financial support, allowing those disadvantaged in society to receive additional resources, and fulfilling the spirit of the deferred prosecution system.



C.Connecting with resources in society to promote judicial protection

It takes but one to move fast, yet it takes many to move far. Judicial Protection is far from a task that any single organization can accomplish, and multifaceted channels, awareness, and connections must be utilized in order to provide comprehensive services and resources. The Taipei District Prosecutors Office keeps closed, permanent contact with the Taipei Honorary Probation Officers Association, the Taipei branch of the Taiwan After-Care Association, and the Taipei branch of the Association for Victims Support, and has also collaborated for more than a decade with the Kunming and Songde branches of the Taipei City Hospital, the Taipei City Center for Prevention of Domestic Violence and Sexual Assault, the Taipei City Employment Services Office, and the Buddhist Fo Guang Shan organization.

In order to broaden services for the general public, the Judicial Protection Center was established on 1 October 2012, with a referral counter at the ground floor to ensure that judicial protection services can be promptly delivered. Services offered are as follows:



1. Defendants who have been detained or are serving sentences, and who have family members in emergency circumstances or other legally defined situations are referred to social welfare authorities.



2. Those needing assistance, or drop-out students who come from highly vulnerable families (e.g. a history of suicide or mental illness) are referred to social welfare authorities.



3. Victims of crime, the rehabilitated, and their families are referred to the Association for Victims Support or the Taiwan After-Care Association.



II. The History and Developments

The judicial protection consists of three sections: the probation, the after-care, and the crime victim support. The three sections have their respective operations while tightly tied to one another to provide comprehensive protections throughout the whole process of the criminal justice. The history and developments of the respective sections are stated as follows.









A.Probation officers and honorary probation officers

The probation and parole system in the Republic of China (Taiwan) originally referred only to probation as defined in the Rehabilitative Disposition Execution Act. This was extended in 2002 to include the execution of community service in conditional deferred prosecutions, and in 2009 to include the execution of social labor services as a replacement penalty.

"Probation" was first defined in Article 63 of the New Criminal Code of 1935, as a type of the rehabilitative dispositions. In this context, the fuction of the probation may exceed those expressly stipulated in the Article 42 of the Juvenile Delinquency Act and the 93 of Criminal Code of Republic of China (the "Criminal Code" hereafter).

To ensure a legal basis for the rehabilitative dispositions outlined in the Criminal Code, the Rehabilitative Disposition Execution Act was passed in July, 1963, of which Article 64 Section 2 clearly stated as follows: "The Ministry of Judicial Administration may establish a probation officer at the prosecutors office at the district court to take charge of probation affairs." This Act came into effect on 1 August, 1964. In April, 1968, the Ministry of Judicial Administration began training for probation officers who passed via the national examination; these probation officers were then assigned to district courts around the country to take charge of probation affairs. Thus was the beginning of the probation officer system in the ROC.

Prior to this, the ROC had a probation supervision system for juvenile offenders: the Juvenile Delinquency Act was promulgated in 1962, with Article 87 of the Act specifically defining that the Act should come into effect on 1 July, 1971. On 11 November, 1970, the Ministry of Judicial Administration promulgated the Provisional Rules for District Courts in Handling Juvenile Delinquencies, establishing juvenile courts in Taipei, Taichung, and Kaohsiung, following which probation officers were installed. After the separation of prosecution and judicial powers in 1980, the supervision of district courts was transferred to the Judicial Yuan, while the Ministry of Justice

was in charge of all prosecutors offices throughout the country. Owing to the need of probation supervision for adult offenders, the Article 64 Section 2 of the Rehabilitative Disposition Execution Act was amended: "The ministry of Justice may establish a probation officer at the prosecutors district office to take charge of the probation affairs ordered to execute by the prosecutors." Following these legal requirement, in 1982 the Ministry of Justice officially installed probation officers at all district prosecutors offices. Current probation officers must have passed Senior Civil Services examinations, and are assigned at the Junior Rank. Under the Regulations for Judicial Personnel, which was promulgated under presidential order in December, 1989, probation officers were explicitly defined as judicial personnel under the segment "other judicial personnel".

From this point forward, the probation system in the ROC was divided into two segments: for juvenile offenders under age 18, probation officers are assigned by juvenile courts at each district court; for adult offenders aged 18 and above,

probation officers are assigned by the each distric prosecutors offices.

Past and present probation directors at the Taipei District Prosecutors Office include Yeh Mu-yan (retired), Li Shu-huei (retired), Lin Mei-ching (retired), Wang Chen-lang (currently probation director at the Chiayi District Prosecutors Office), and Tseng Hsin-tung (current director). Many former probation officers at the Taipei District Prosecutors Office have gone on to serve at other high-level positions; these include current New Taipei City Government Secretary-General Hsu Yu-ning, current Director of the Center for Crime Prevention Wu Yong-da, probation director at the New Taipei District Prosecutors Office Chang Hao-yi, probation director at the Shilin District Prosecutors Office Yang Ying-ying, probation director at the Hsinchu District Prosecutors Office Huang Chi-chung, and former probation director at the Yilan District Prosecutors Office Huang Chin-dao. Many probation officers at the Ministry of Justice and Taiwan High Prosecutors Office have also served at the Taipei District Prosecutors Office.

Probation is a non-institutional penalty and compulsory supervision which actively promotes reformed and better behavior, while prevents crime or the repetition thereof. The system offers moral guidance for its subjects, as well as support for employment, education, medical, and care as necessary. Its mission requires personnel, material, and financial support. In order to integrate resources from society at large and improve the efficacy of the probation system, the Ministry of Judicial Administration adopted a voluntary probation system, and issued a set of twelve acts governing the voluntary probation system through an order issued on 19 February, 1970, thus allowing the establishment of a voluntary probation system.

This was the beginning of the honorary probation officer system in the ROC. Honorary probation officers were selected by chief judges of district courts and chief prosecutors at district prosecutors offices according to their needs, with the aim of promoting good, moral behavior for better integration with society. Since these probation officers offered their services

voluntarily, devoting their own time, money, and effort, on 12 June, 1971 the Ministry of Judicial Administration issued an order to rename "voluntary probation officers" to "honorary probation officers".

After the separation of prosecution and judicial powers on 1 July, 1980, district courts now came under the jurisdiction of the Judicial Yuan, and no longer belonged to the Ministry of Judicial Administration. Beginning in 1983, the Ministry of Justice instructed district court prosecutors offices to actively select and employ honorary probation officers. These were people and organizations who were willing to offer their time and effort to furthering a just society, and included lawyers, accountants, doctors, teachers, elected representatives, civil servants, members of religious orders, businesspeople, and organizations involved in social welfare, education, public health, religion, and charity. Honorary probation officers carry out their duties as "other qualified persons" as listed under the Criminal Code and Rehabilitative Disposition Execution Act.

Probation duties as carried out by probation officers and assisted by

honorary probation officers are governed by relevant laws and regulations; in addition to this, probation officers and honorary probation officers should take into account the mental wellbeing and social abilities of those under their charge, and adequately employ resources available under their respective jurisdictions. The Taiwan After-Care Association, a stiftung foundation supervised by the Ministry of Justice, is another crucial resource that probation officers may draw upon.

B. After-care

According to the Branch of the Taiwan After-Care Association, branches of the Association may be established at district courts or district court branches. Each branch of the Taiwan After-Care Association is comprised of a committee of 7 to 15 members invited by the central association; these include Chief Judges of district courts or district court branches, Chief Prosecutors of district prosecution offices or their branch offices, municipal mayors or county magistrates, speakers of county or municipal councils, prison directors, and other qualified persons.

On 9 June, 2000, the Ministry of Justice issued a request for rectification: since the chief prosecutor of the Taiwan High Prosecutors Office also served as chairperson of the Taiwan After-Care Association, and chief prosecutors of district prosecutors

offices also served as chairpersons of the branches thereof, in which cases might be deemed a volation of Civil Servants' Service Act; furthermore, funding for the Association should be altered to become project-based, with funds allocated according to budgets drawn up for each project. Such changes would heavily impact the Association's mission, as well as its personnel management.

As outlined by the Ministry of Justice, as the supervisor of the Taiwan After-Care Association, the Ministry of Justice should not be in a capacity that would allow self-policing; chief prosecutors, who fall under the jurisdiction of their respective prosecutors offices and therefore the Ministry of Justice, should withdraw from the boards of the Taiwan After-Care

Association and its respective branches, with their roles in the Association being replaced by other qualified members of society.

After the Association met to discuss these changes, the meeting's conclusions were reported to the Ministry of Justice: current board members would serve until the end of their terms (the seventh board), at which point they would hand over to new members of the board selected under the new rules; meanwhile, the Association's branch would be amended as quickly as possible, and sent to the Ministry of Justice for approval. The seventh board would have served from 11 November, 1996 to 10 November, 2000; however, after approval from the Ministry of Justice, board members were allowed to serve until

the eighth board took over; the terms of committee members of each branch were likewise allowed to extend until members of the the eighth term of the board took up their positions.

The Association needed to draw up new plans for all aspects of its functioning, including its regulations, administrative details, organizational structure, personnel, accounting, offices, equipment, and other tangible and non-tangible material. A request issued by the Ministry of Justice on 13 June, 2002 requested that chief district prosecutors seek out qualified individuals to serve as heads of branch committees

and on the board of the Association's central committee; in addition, the Ministry also requested that the Association's branch be amended. Draft amendments to the branch were submitted for discussion on 21 November, 2002 at the seventh board's 11th meeting; after the draft was passed, it was submitted to the Ministry of Justice, which responded on 25 December, 2002 with its corrections, and requested that the Association expedite the proceedings for altering its registration under ROC law. On 27 December, 2002, the Ministry of Justice issued a formal letter appointing Wu Guo-ai and 21 other individuals to



the eighth board of the Association, with individual appointment certificates sent to the Association. On 3 January, 2003, the Association's central office issued a formal request to its branch offices for the selection of branch committee members. On 12 February, 2003, the Ministry of Justice issued an approval of the Association's new seal as a stiftung foundation, which had been registered under the Taipei District Court, and now came into effect. The Association transitioned into its current form on 1 January, 2003; those taking office on that day included the Association's eighth board, the first comptrollers, and committee members of branch offices, with terms running from 1 January, 2003 to 31 December, 2005. Chief district prosecutors, who originally doubled as directors of each branch office, now became honorary chairpersons, with qualified members of society serving as active chairpersons.

The Taipei branch of the Taiwan After-Care Association began as the Taipei Renewal Society established in 1906; branch offices in different regions were only unified under the same name after the Taiwan Provincial Judicial Protection Association was established on 11 November, 1946.

C. Crime victim protection

1. Legislation history

The draft Crime Victim Compensation Act, completed in February, 1995 and submitted to the Executive Yuan for approval, was intended as supplementary, stop-gap legislation; those eligible for compensation were restricted to "victims who suffered severe injuries as a result of crime, or in the case of death, the living family members of those victims", and only "when the perpetrator of the crime is unknown, or the perpetrator has no financial means to compensate the victims, and when the victims are in financial trouble owing to said crime". After three years of deliberation in the Legislative Yuan, the name was changed to Crime Victim Protection Act, under which name the bill was passed in the legislature on 5 May, 1998; the Act was promulgated on 27 May, 1998, and came into effect on 1 October, 1998. In addition to establishing

a system for victim compensation to lessen the burden for crime victims or their families, the Act also stated that the government should establish an organization for victim protection, and that a total of 14 protective services, including medical care, should fall under the purveyance of this organization. Thus the Act served to establish victim protection services in the ROC: in addition to financial aid, victims should also receive assistance in recovering physical and mental health, and in rebuilding their lives.

The Crime Victim Protection Act was amended for the second time on 1 August, 2009; this was because victims of sex crimes would often suffer from severe post traumatic stress disorders, are unable to recover into a normal functioning life in a short time, and as a result often suffer as much from the prolonged effects of the crime as the crime itself, if not more so. The amendment thus added victims of sex crimes into protection, providing compensation and protection as needed. Moreover, compensation was widened to include mental and psychological distress, and protection was extended to foreign-

born spouses and laborers; this was due to the large number of foreign marriages and migrant workers in Taiwan in recent years, which saw a spike in spouses or workers from Mainland China, Hong Kong, Macau, and other countries suffering abuse.

As more and more people travel across borders for tourism, business, marriage, employment, and education, governments around the world have increasingly needed to take into account the human rights of foreigners. Crime victim protection is an important indicator of a country's human rights protection; yet because the current Crime Victims Protection Act operated on a principle of mutual benefit for foreign victims, it did not fall in line with the modern-day principle of ensuring equal rights, nor did it adhere to the spirit of the International Covenant on Civil and Political Rights. Because of this, an amendment in November, 2011 removed the "mutual benefit" clause for foreigners, and the newly amended Act came into effect on 10 December, 2011. This made Taiwan the first in legal protection for foreigners in Asia: the Act now includes foreigners and stateless individuals residing in Taiwan in its protections, adhering to the standards set out in the International Covenant on Civil and Political Rights, and demonstrating the ROC government's emphasis on human rights.

The Crime Victim Protection Act is a jus soli law that applies to crime victims within the territory of the ROC; however, since the "mutual benefit" clause was removed in the amendment promulgated on 30 November, 2011, foreigners who are the victims of crimes now have legal recourse, while Taiwanese nationals abroad cannot apply for compensation according to the Act, which resulted in many Taiwanese mistakenly thinking that the government offers better protection to foreigners than its own citizens.

Taiwanese nationals are increasingly spending short periods of time abroad for employment, education, business, marriage, tourism, and professional requirements, yet if they lose their lives as a result of deliberate acts perpetrated against them, they still have strong ties to their home country. Under these situations, family and relatives of the victim must deal with foreign authorities for legal recourse and compensation, which often puts them at a financial disadvantage. To remedy such situations, the Act was further amended on 22 May, 2013, with the amendment coming into effect on 1 June, 2013. This amendment established protection and emergency funding for the families of victims who lost their lives due to deliberate acts perpetrated against them abroad, which signified a landmark in human rights protection in the ROC. In addition, the amendment also increased the number of individual items that crime victims can apply for compensation, and reduced the regulations pertaining to these applications; these included funeral expenses less than NT\$200,000, which can now be obtained without submitting any documentation, and the requirement that social insurance (other than compulsory automobile liability insurance) be deducted from the compensation.

2. History of the Taipei branch of the Association for Victims Support

After the Crime Victim Protection Act was passed in May, 1998, the Association for Victims Support was established in January, 1999 to provide psychological, material, and legal services for those who suffered serious injuries as a result of crime, or in the case of crimes resulting in the death of the victim, their family. The Taipei office was established on 1 April, 1999, with the Chief Prosecutor serving as chairperson. The office was upgraded to a full branch association on 12 December, 2003, drawing on members of society for its committee, with Central Hill Medical Clinic director Liao Ying-tsang serving as committee chairperson, and the Chief Prosector of the Taipei District Prosecutors

Office serving as honorary chairperson. Committee members serve three-year terms, with the current committee being the fifth in the Association's history. Committee members are drawn from qualified members of society, and their efforts have brought wider acknowledgement of the importance of victims protection.

The Taipei Association currently has executive, general affairs, and accounting secretaries, which positions are respectively served by the Taipei District Prosecutors Office's chief court clerk, data division director, and an administrative assistant. In addition, the Association also has three full-time staff members, and another project assistant secretary to assist in the Association's functions.

The Taipei Association also recruits volunteers for its mission of victim protection, with each volunteer serving three years. The Association currently counts a total of 45 volunteers, who assist in visiting crime victims and promoting the Association's mission.

According to the Article 30 of Crime Victim Protection Act, the Association for Victims Support offers the following services:

- Help crime victims secure emergency physical and mental treatment and places to stay.
- (2) Assist crime victims in the course of the judicial investigation or trial, and after the conclusion of the trial.
- (3) Assist crime victims in applying for compensation, social relief/aid and in

- making civil claims.
- (4) Assist crime victims in investigating the property of the persons committing the criminal acts at issue and the property of the persons liable for indemnification for the damage arising from such criminal acts.
- (5) Assist with the personal protection of crime victims.
- (6) Assist crime victims in obtaining medical treatment to treat their physical and mental injuries, rehabilitation and returning to their normal lives, and occupational training.
- (7) Advocate the protection of crime victims.
- (8) Provide other assistance.

III. Analysis and Statistics

A. Probation Cases

The Ministry of Justice has put emphasis on the intervention of offenses against Drug Control Act, public safety, and sexual autonomy. Cases are different in nature, and thus require various networks for interventions; the connection, coordination, communication, cooperation, and provision of professional opinions and members across various networks have constructed an important model for current implementation of probation.

The number of probation officers at the Agency and caseload are as follows: currently, there are 15 probation officers, one clerk, one clerk assistant, 13 probation assistants, and 3 urine sampling technicians at the Agency. With regard to probation for cases of sexual assault and domestic violence, and deferred prosecution and rehabilitation of drug and DUI convictions, special units have been established as the implementation involves professional medical therapy and the establishment of

preventive networks. At the end of August 2017, the total number of probation cases reached 3,656, and each section was responsible for an average of 261 cases. Most of the cases were suspended punishment/deferred prosecution with conditions (including therapy and rehabilitation), followed by probation cases, and then labor service/community service.

Probation officers shall comply with the relevant laws and regulations, as well as important orders of the Ministry of Justice. Article 74 of the Rehabilitative Disposition Execution Act: "With regard to those that are subject to probation during probation or parole, the probation officer shall be aware of their daily actions and people they are in contact with". Article 74-2: "The person subject to the probation shall comply with the following affairs during the period of probation: 1. Marinating good behaviors and staying out of contact with those with bad behaviors; 2. Complying with the orders given by the prosecutor and the probation officer; 3. Shall not

offend the victim, complainant, or informer; 4. Reporting his/her physical health, living conditions, and working environment to the probation officer at least once a month; and 5. Unless approved by the probation officer, he/she shall not leave the location of probation. An approval of the prosecutor shall be acquired if leaving more than ten (10) days;" Article 74-3: "When the person subject to the probation seriously violates any of the subparagraphs of the preceding article, the prosecutor may apply for probation or revocation of the declaration regarding the probation. With regard to those that are under the parole, if the situation prescribed in the preceding paragraph occurs, the warden may apply for revocation of the parole."

Probation officers classify cases of various types based on convictions or the relevant grading system; for serious offenses or those cases deemed to have medium or high likelihood of recidivism, probation officers will register and monitor them as core cases and undertake the intensive probation program. In an intensive probation program, probation officers arrange frequent interviews and

quick visits with probationers to monitor their life, work, and friends, and take supervisory guidance measures (Ministry of Justice Letter No. 0931001002 issued on July 14, 2004) to assist in the reintegration of the rehabilitated, achieving the goal of preventing recidivism.

- 1. Probation officers shall conduct the first visit within two months after taking on the case, in order to gain timely knowledge of the probationer's relationship status with his/her family, relatives, friends, employers, colleagues, and neighbors.
- 2. Probation officers shall order probationers to report to them at least twice a month in the six months after their first report, and the number may be increased if necessary. Probation officers shall also irregularly track probationers' whereabouts via phone calls or visit and interview probationers regarding contents of their reports. Probation officers may also order probationers to regularly report to them on status of daily life, work, and friends, via phone calls.
- 3. Probation officers shall review at least

once every half year the intervention program for the probationers based on their reports and case implementation. Any adjustments to the intervention program must have prior approval by the chief probation officer.

4. When probationers violate probation rules or fail to report on time, probation officers shall immediately issue a written warning and order the probationers to report back more frequently and promptly; for serious violations, probation officers shall immediately report to the prosecutor in charge.

Cases with high risk of recidivism are registered and monitored as core cases. The registration and monitoring rate is about 13%. Each division executes 250 probation cases each month. Probation officers register cases with high risk of recidivism as core cases and conduct 2 to 4 interviews and visits per month, coupled with multiple visits by police officers for intensive supervision in order to prevent recidivism.

1. Strengthen Protection for Women and Children:


Establish special units of probation officers for sexual assault and domestic violence: Targeting sexual assault and domestic violence probationers.

The special sexual assault unit consists of two probation officers, executing approximately 160 cases; each probation officer averages around 80 cases. Every two weeks, the chief probation officer hosts a sex offender review meeting, and each quarter, the chief prosecutor invites members of sexual assault prevention network, including personnel, scholars, and experts, of social affairs, police administration, health administration, and physical and psychological therapy, to convene community monitoring and guidance taskforce meeting. As of April 2017, a total of 7 probationers with medium to high risk of recidivism are registered, and electronic monitoring is being implemented on 7 persons. The domestic violence unit consists of two probation officers, executing approximately 50 cases. Group therapy for domestic violence offenders is held monthly, and probation officers also interview and visit probationers to further prevent recidivism.


2. Strengthen rehabilitation of drug offenders with deferred prosecution to improve outcome of therapy:

The Agency now executes 665 cases of rehabilitation of drug offenders with deferred prosecution, referring probationers to Taipei City Hospital Kunming Branch (Category 1 and 2 drugs), Songde Branch (Category 2 drugs) for rehabilitation. Also, the Agency has worked with Holistic Detox Association to organize mindfulness-based stress reduction classes and talks on rehabilitation, which are based on the mindfulness-based stress reduction (MBSR) program developed by Professor Jon Kabat-Zinn. The program helps drug users to enhance their willpower to quit through meditation, mindfulness training, concentration training, and improvement of physical and mental health. Also, referencing the method of Narcotics Anonymous from the U.S., the Agency invites individual drug users to share journeys of rehabilitation with one another and encourage and motivate each other. Furthermore, to enhance family support for drug users, the Agency held 2 drug addict family day events in 2017, inviting drug users and families to the Taipei Zoo, or see a movie together, carrying out anti-drug promotion for children and parents through fun activities.

Execution of rehabilitation of drug offenders with deferred prosecution: drug offenders are referred to the hospital by prosecutors, and after assessment by the







hospital, prosecution may be deferred with mandatory rehabilitation therapy. These probationers will then receive guidance and are subjected to intermittent urine tests. Deferred prosecution for Category 2 drugs mainly focuses on rehabilitation therapy, and over the past two years, the completion rates of therapy have exceeded 60%, which shows that probation guidance can effectively improve the outcome of rehabilitation and therapy.

3. Recidivism Prevention and Cognitive Group Therapy for Domestic Violence Probationers:

Help domestic violence probationers understand their own actions and behaviors and the consequences of their actions through cognitive group therapy, so they can learn to control themselves, preventing future acts of domestic violence

4. Employment Assistance for Probationers:

Employment is a key indicator of recidivism rate. To facilitate employment, the Agency not only joins forces with Taiwan After-care Association Taipei Branch for employment referrals, but has also launched two employment facilitation programs:

a. Cooperate with Taipei City Employment
Services Office to organize "Group
Seminars for Unemployed Individuals":
Targeting those who have just been
released from prison, the program
combined with monthly probationer
employment guidance and job matching
event held at the Employment Services
Office help probationers find jobs or

participate in vocational training for smooth reintegration.

- b. Cooperate with Taipei Honorary
 Probation Officers Association to
 organize employment transition
 program: Some probationers and the
 rehabilitated may lack the ability to
 work due to disabilities or age and
 have difficulty finding employment. The
 Agency cooperates with cleaning squads
 to design employment facilitation
 programs, allowing probationers to
 work and earn income immediately
 and helping the rehabilitated and
 probationers to successfully find
 employment and gain stability in life.
- 5. Strengthen Alcohol Rehabilitation Therapy for druken driving offenses against Public Safety:

Starting in 2015, the Agency cooperates with Taipei City Government to launch "Taipei City druken driving Medical Intervention Program," referring druken driving offenses to Taipei City Hospital Songde Branch for alcohol rehabilitation in aim to prevent druken driving. By July 2017, a total of 226 offenders had been referred

(130 cases of deferred prosecution, and 96 cases of druken driving commutation to fines and labor services).

6. Religion and Life Education Guidance:


To enhance life education, the Agency cooperates with Fo Guang Shan, Dharma Drum Mountain, Yi Kuang Orphanage, Genesis Social Welfare Foundation, and Hondao Senior Citizen's Welfare Foundation, to organize religious guidance, the six ethics of mind life education, seminars by renowned speakers, and community service life education. The events for spiritual development and inner growth are organized monthly to prevent recidivism from within.

7. Execution of labor services:


The Agency executes around 400 cases of labor service, selecting 19 executive organizations of labor service within the jurisdiction, including cleaning squads, district offices, Genesis Social Welfare Foundation, and Yi Kuang Orphanage, to launch social labor services such as cleaning the environment or serving disadvantaged groups. The completion rates exceed 80%.




cases of phones calls in 2017 (including cases of high risk recidivism)

IV. After-care Cases

The Branch's concrete quantitative objective is to reduce the rate of recidivism. As for qualitative improvement, the Branch aims to adjust the mindset of aftercare staff to change the status quo and enhance performance, help prisoners and rehabilitated ex-offenders (hereinafter as "the rehabilitated") to change criminal thinking, and strengthen family support for the rehabilitated to reconstructing their values and interpersonal relationships and guide them onto the right course in life.

- 1. Overall Principle: The Branch aims to design integrated measures to actively bridge correction and protection and link after-care and probation, and help released the rehabilitated to reconstruct correct values and behavioral model, enabling they to survive in the society on their own and preventing recidivism.
- 2. Forward-looking Principle: The Branch makes planning for preventive measures based on reasons and trends of recidivism and advocate and promote key initiatives such as adoption-guidance programs and anti-drug education in order to foster a law-abiding and peaceful society.

- 3. Individualization Principle: The Branch practices the idea of individualized guidance, providing the rehabilitated who may need protection as prescribed by law, such as the rehabilitated who are in need, guidance or referral for education, employment, and homecare, as well as measures including follow-up services.
- 4. Community-based Principle: The Branch aims to implement the concept of community-based after-care, coherence community consciousness, galvanize community resources and private organizations to recruit volunteers, and coordinate community residents to jointly participate in after-care.

The After-care program provides guidance to nearly 50,000 the rehabilitated every year. Currently, there are only 60 full-time staff members in Taiwan, and most of the time they cooperate with social welfare organizations and volunteers for the execution of various tasks. Both the number of the rehabilitated proactively seeking help and the number of the rehabilitated reported by prison to require related services have been growing over the years. After-care initiatives are as follows:



1. Individual Guidance

The Branch provides juvenile and adult probationers and the rehabilitated, assistance, referral, guidance, companionship, and care for issues and needs such as placement, employment, medical treatment, skill training, business start-up loan, ID application, healthcare insurance, drug addiction treatment, alcohol addiction treatment, psychiatric rehabilitation, and assistance with family dysfunctions.

2. Cooperation with Social Welfare Organizations on Placement

To prepare them for reintegration, the Branch provides short-term placement for homeless HIV-positive the rehabilitated before AIDS, offering classes on AIDS-related information, emotional support, and health education, as well as employment information and assistance for difficulties in life. Also, group and individual guidance are conducted to help the rehabilitated's enrich their mind and spirit.

Throughout the year, the Branch organizse "HIV Harm Reduction, Group Aftercare, and Employment Promotion" seminars intermittently, introducing to HIV-positive the rehabilitated after-care related programs and employment information. During holidays and festivals, the Branch raises rice, gift boxes, rice dumplings, sausages, pork floss, crackers, canned goods, clothes, comforters, and magazines to donate to halfway houses.

3. Employment Guidance

To provide the rehabilitated employment guidance, the Branch visits correctional institutions monthly to offer inmates psychological counseling, vocational education, and employment and start-up guidance in aim to facilitate employment. Through follow-up guidance after release, the Branch also strives to motivate individuals to seek employment. Unemployed the rehabilitated or those who are looking to change jobs are invited to a meeting at the Branch to learn more about his or her employment motivation and interests. The Branch offers guidance on the proper employment mindset and suggestions and helps them find appropriate jobs based on their

qualifications or issue referral forms and certificates of protection for the rehabilitated to refer them to Taipei City Employment Services Office.

The Branch also encourages businesses to provide the rehabilitated with employment opportunities, establishes database of cooperating companies, informs individuals of job opportunities, and carries out job matching. When the rehabilitated have job-related or interpersonal issues that need to be communicated with their employers, the Branch will provide assistance and guidance, so that the two parties can resolve the issues, quickly ensuring stable employment. As for individuals, the Branch will provide follow-up guidance for 3 to 6 months depending on their employment stability before closing the cases.


4. Emergency Assistance

When the rehabilitated, his or her spouse, or direct blood relatives, encounter serious accidents or disasters, and have financial difficulty to deal with the situation, the Branch will maintain contact with Department of Social Welfare of each municipal government to jointly help the said the rehabilitated with application of emergency assistance, low-income family subsidy, census register, personal ID, and employment referral and guidance; the Branch also works with private social welfare organizations and charity groups, such as Hsin Tung Yang, Kuo Yuan Ye, Da-Yao Printing, Fubon Charity Foundation, Chang Yung-Fa Charity Foundation, PXMart Charity Foundation, and Legal Aid Foundation, to consolidate resources of each organization and provide the rehabilitated comprehensive services and aids.


5. Follow-up Visits to The rehabilitated

The rehabilitated, who have applied for after-care or are reported cases, will be evaluated after receiving guidance; follow-up guidance and after-care will be provided to those who require continued guidance and check-up, in order to help them resolve issues relating to education, employment, and medical treatment. Follow-up guidance will be provided for individuals participating in vocational training, placement program,

Number of Cases by Year





Number of Cases of Employment Guidance by Year

Number of Placement in Cooperation with Social Welfare Organizations






employment guidance, and start-up loans, or when the rehabilitated are contractors or work at business entities.


6. Follow-up and Visit upon Notice

Upon receiving after-care notice from correctional institutions, local courts, district prosecutor offices, or other agencies, the Branch will create official documentation of a specific case, which will be stored in the computer database under an assigned serial number. Based on the notified situation, the Branch will appoint staff member or after-care counsellor to follow-up and visit the rehabilitated and provide timely assistance when the rehabilitated are in need; or, the staff member or after-care counselor should provide aid by integrating social resources. When correctional institutions issues


Number of Follow-up Visits to the Rehabilitated




Number of Cases of After-care Follow-up and Visit with Notice

letters inquiring details of an the rehabilitated's application for professional license or participation in short-term vocational training, the counselor or appointed staff member shall contact the rehabilitated via phone or visit them, and report the results of investigation back to the correctional institution.

7. Travel and Transportation Subsidy

Subsidies are provided for the rehabilitated who have just been released but have no money to return home, become unemployed in another town or city, or are visiting a friend but cannot find the friend, and have difficulty returning home; for the rehabilitated who have mental or physical disabilities, or are handicapped, too old, or too young, and need someone to take care of them on their way home; for released

inmates who have mental and physical disabilities and are homeless, who need to be admitted to relief agency or medical institution for placement or treatment; for the rehabilitated who have just been employed and need money to travel to the place of employment.

8. Accommodation and Meals Subsidy

Subsidies are provided when a released inmate is too far away from home and needs to board an automobile, ship, or plane home but cannot afford accommodation and meals as they wait for their means of transportation; or when a released inmate is being transported to a medical or placement institution due to mental or physical disabilities but cannot afford accommodation and meals during the trip.

V. Victims Support Cases



Between 2012 and 2015, the Association for Victims Support Taipei Branch (AVS Taipei Branch) maintained a caseload of 140 cases annually. The number dropped to 90 in 2016. This is attributed to staff turnover, more stringent review standards and the implementation of case screening. Thorough case reviews may effectively allocate public and private resources for the victims and their families who have actual needs. The approach is also the answer to a public outcry on inadequate victims support.

Services provided by AVS mainly include Litigation and Compensation Service, Emergency Assistance and Protection, Family Care and Rehabilitation, and Physical/Mental Care and Counseling. Among them, Litigation and Compensation Service as well as Physical/Mental Care and Counseling are the focus for the Taipei Branch.


A.Litigation and Compensation Service

1. Legal and Litigation Aid


Legal and litigation aid includes drafting court documents, representation in court, and legal counsel with lawyers and Branch staff. Legal aid has always been one




The percentage of AVS Taipei Branch services in 2012-2017




The cases of Legal Aid









of the priority support services provided by the AVS Taipei Branch. When tragedies occur, victims are in the most urgent need of addressing legal issues. The number of individuals served by legal support increased from under 200 in 2012 to nearly 600 in 2015. Although the number dropped to below 300 in 2016, legal aid will remain the emphasis for AVS Taipei Branch in the future.

2. Investigation Assistance

An average of 250 people received investigation assistance annually for the past 5 years. In addition to cases that are opened each year, AVS Taipei Branch also assist victims and their family members who have obtained certificate of the obligatory claim to conduct search on debtor's property records. No additional fee is incurred for the property search conducted through AVS, and the Branch also takes this opportunity to establish contact with family members to better understand their living conditions and gain additional information.

3. Compensation Assistance

The number of people applying for compensation decreased in 2016 compared with the past few years. This is

mainly due to the lower number of cases opened. In 2017, Branch volunteers started raising awareness on compensation money available for victims.

B.Emergency assistance and protection


AVS Taipei Branch may award an emergency assistance fund after assessing a family's financial need. Victims' families often suffer severe financial hardship when the crime just occurred, and certain financial assistance may help solve their problems while bridging the connection between them and the Branch.

C.Family care and life rehabilitation


1. Consolation

Visitation and consolation has always been one of the major tasks for the AVS Taipei Branch. It provides the opportunity to closely observe victim's family and financial conditions. It is also an excellent opportunity to test the effectiveness of volunteer training. During the visit, the Branch may identify first-hand the family's actual needs rather than obtaining information from a secondary source.


The cases of Emergency Financial Assistance




The cases of Visitation and Counsolation








The cases of Career Guidance

In 2016, AVS Taipei Branch visited over 600 individuals at an average of 7 times visits per case annually. Visitation and consolation is also seen as one of the best ways to establish a relationship with the victim's family.

2. Educational Assistance

Educational assistance is provided for families with school children experiencing financial hardship. The number of applicants decreased in 2016 because many recipients graduated in the past two years, Taipei is urbanized and its population is aging rapidly, and many families are without children. Educational assistance effectively alleviates the financial pressure for families in need. It is also one of the priorities for the Branch.

3. Employment Enhancement Program

AVS established the Employment Enhancement Program in order to help victims and their families acquire professional skills, gain employment opportunities and solve financial problems. This program also aims to help achieve mental rehabilitation and skill training.

The focus for the Employment Enhancement Program in 2016 was skill training. This program not only provides skill training but also brings physical and mental improvements. As shown in the table below, the number of people receiving employment assistance has grown fourfold compared with a few years ago. The program invites victims and their families to participate in various activities and provides skill training as one of its key focuses.


D. Physical/Mental care and counseling

Physical/mental care and counseling has been the focus for AVS Taipei Branch in recent years. The Branch hopes to help alleviate the pain of victims and their families and therefore promotes the "Kindness Program" with tremendous efforts. The program provides psychological counseling in hope of helping victims and their families discover their own potential, move beyond the pain and improve their physical and mental conditions. In the past five years, over 100 individuals have received counseling service each year. Counseling, one of the key priorities for



the AVS Taipei Branch, may rehabilitate victims or their families physically and mentally. In Taiwan, people often neglect mental health. However, mental conditions may lead to major disturbance in life. The Branch provides counseling service in order to help victims and their families restore their lives back to normal.

VI. Judicial Protection Strategies



With a highly educated and cultured public in its jurisdiction, the Taipei District Prosecutors Office requires a deeper, more attentive approach in its services and connections to other resources. Even with the multitude of public and private sector resources within the jurisdiction, these requirements nevertheless pose significant challenges, and therefore strategies employed are as follows:

- 1. Core leadership and division of labor:
 The Chief Prosecutor is charged with substantial duties, and therefore judicial protection work is assigned to multiple teams of Head Prosecutors, with detailed responsibilities assigned by the director of each team. The Chief Clerk and Chief Probation officer are tasked with monitoring probation affiars, after-care projects and vicitms support.
- 2. Integration both within and without: In addition to the main judicial protection services of probation affiars, aftercare projects and vicitms support, each division within the Taipei District Prosecutors Office is tasked with separate responsibilities, with all divisions working closely together. Qualified private sector companies and expert non- profit organizations are also involved in judicial protection work.
- Public sector resources as a focal point for the judicial protection network: The multifarious public sector resources within the jurisdiction allows a wide and comprehensive network with prompt services. Networks for crime prevention, community service, judicial protection center services, general legal education,

- rehabilitation, victim protection, and care for vulnerable students all tap into resources offered by the health, police, medial, social welfare, and education authorities, which are combined into a judicial protection network offering prompt services.
- 4. Financing charity organizations with deferred prosecution fines: Fines accumulated through deferred prosecution are used to subsidize charity and social welfare organizations, to assist in protecting those most vulnerable in society and ensure the prevention of crime.
- 5. Protection of women and children, combatting addiction, and preventing drunk driving: These three aspects are at the core of crime prevention, and comprehensive meetings of networks of sexual assault, domestic violence offenders, and drug addicts serve to monitor their probation and progress in therapy. Drunk drivers are required to attend legal and life education courses to prevent repeat offences and ensure public safety.

- 6. From in-prison to outside support:

 Care and emotional warmth are
 brought inside prison walls through
 family members, social resources, and
 the rehabilitated who have launched
 successful careers. Occupational skills are
 taught within prisons, while support and
 employment assistance is offered after
 release from prison, to better enable the
 rehabilitated to return to society.
- 7. Legal assistance and counseling for crime victims: To prevent crime victims and their families from missing out on their rights because of a lack of knowledge of judicial procedures, legal assistance is offered throughout the process. In addition to connecting individuals with legal assistance organizations, victims and their families are offered free legal counseling and assistance through judicial procedures. Victims are also offered counseling and assistance to rebuild their lives.
- 8. Establishing restorative justice: As restorative justice is in its early stages, the Taipei District Prosecutors Office and the Taipei branch of the Taiwan After-Care Association collaborate closely to

- establish such a system. Measures include monthly meetings of task forces involved, prosecutors referring cases to relevant associations, and an annual year-end meeting and dinner chaired by the Central Hill Madical Clinic director Liao Ying-tsang.
- 9. Volunteers engaged in comprehensive monitoring of individual cases: Volunteer workers are involved in probation and crime prevention work, to ensure that each case receives adequate attention, and assist in broadening the scope of work.
