I. Background

Office 3 was originally located at 1&2/ F, No. 185, Section 2, Xinhai Road, Da'an District, Taipei City (Central Baishi Building), which is considerable far from the Office. In view of the fact that the office building of the Office is not enough for use and the new judicial building where the Office is located is restricted for expansion, therefore, the only option was to request the appropriation of nearby available public building from National Property Administration, Ministry of Finance to renovate and use, in order to save huge amount of rent required for renting office buildings and be able to effectively manage the office. The public building appropriated for the Office 3 renovation project is located at the Procurement Building of the Ministry of National Defense (No. 172-1, Bo'ai Road, Zhongzheng District, Taipei City). The land is a state-owned property and the manager was Armaments Bureau, Ministry of National Defense. Upon the persistant effort of Ministry of Justice, Executive Yuan agreed to appropriate the building to the Office after Ministry

of National Defense moved to Dazhi Boai Camp. After the building completed the approved relevant renovation and procurement pursuant to the provisions of the Government Procurement Act and Prosecutor Investigators of the primary user units moved in, people who contact the Office for business or court session can avoid the inconvenience caused by going to the wrong office. After the Office added more Investigation Rooms in the space vacated, it further solved the Investigation Room shortage issue and the difficulty of having to queue up to use the Investigation Room which delays the investigation, while improving the investigation efficiency in respond to the increasing amount of procuratorial business, as well as improving the judicial quality, promoting social justice, greatly benefiting the quality and performance of case-solving, the promotion of rule of law, litigation counseling and other aspects of works, and making it convenient for the people to contact for business.

II. Reasons and Source of Funds

- 1. In accordance with the approval and instruction specified in Document No.Fa-Zong-10401505530 issued by the Ministry of Justice on 25 June 2015 concerning the "Renovation Project Plan and Estimated Budget for the Construction of Additional Investigation Room to the Office Building and Old Offices in the Procurement Building of Taiwan Taipei District Court Prosecutors Office".
- 2. Total costs of the plan approved by the Executive Yuan:

The cost of the plan was original budgeted at the amount of NT\$79,737,141 on 25 June 2015. However, upon the negotiation during the meeting with the Ministry of National Defense on 16 February 2016, the Ministry of National Defense required the installation of

louver protection and shielding facilities on the side facing the military camp and keeping its mailroom at 1/F of Building B. In addition, since the original design plan did not take water seepage of the doors & windows, typhoon damages on 4/F rebar truss roof and carcinogenic issue of asbestos building materials into account, therefore the original design plan shall be adjusted to add the door/window project, the louver protection and shielding project, replace the asbestos tile and other projects. After the Office submitted the revised plan to Taiwan High Prosecutors Office on 25 March 2016 for review by the Ministry of Justice and Executive Yuan, the Executive Yuan issued Document No.Yuan-Shou-Zhu-Yu-Zheng-1050101147 on 23 May 2016 approving the revised total costs of NT\$92,702,000 for the plan.



IV. Pre-Renovation Status Survey

The Procurement Building (the Office's Office 3) is located in Bo'ai Special Zone with one basement level and four storeys. The foundation is adjacent to the Bo'ai Road connected with Building A & B, where were all completed on 24 January 1964. The four-storey building was built after 1978 and was formerly subject to the Ministry of National Defense. After the Ministry of National Defense moved to Dazhi Boai Camp in December 2014, the Procurement Building office located at No. 172-1, Bo'ai Road, Taipei City was granted upon resolution between the Executive Yuan, Ministry of National Defense and Ministry of Justice to be used by the Office.

The building was an old military building of more than 40 years old. Not only was it lack of relevant seismic resistance structural safety information, the Ministry of National Defense was also unable to provide floor plans for each floor of the building. In addition, due to issues such as the change in demand, the building was old and flooded, the main equipment were also old, the air-conditioners were relocated, overall poor equipment efficiency, and the building materials or space planning back then do not meet the requirements of the current Building Control Act and Fire Services Act, the Procurement Building required renovation or additional construction to re-plan air-conditioner with five major pipelines, fire-prevention refuge facilities, fire-fighting equipment and other construction items. The following table shows each floor prior to the renovation.







B1F	Divided into Building A zone and Building B zone, each equipped with single staircase to 1/F. Building A was original used as an office space, while Building B was used for offices. Upon survey, the structural part of Building B (next to the lobby) was found backfilled with cobblestone layer. 








VIII. Process of Design Changes

A. The Construction Period and Amount Increased due to First Design Change on 16 June 2017

The original contract was NT\$69,880,000, which became NT\$75,957,347 after the change, and the completion date set at 5 October 2017 (construction period increased from 270 days to 313 days). The first design change took place because the original concrete was low in strength with poor floor slab thickness and reinforcement, the basement leak was severe, the roof required heat insulation, the rebar truss and corridor on 4/F was severely rusted, VRV and related electromechanical equipment were insufficient and in need of an expansion, the entrance stairs requires improvements, and, upon the Chief Prosecutor made a visit on 9 May 2017, it was instructed that 1/F circulation must be adjust to leave no security or visual blind spot.




Renovation Project for the Offices in the Procurement Building of Taiwan Taipei District Court Prosecutors Office (in line with the first revision)





B. The construction period and amount increased due to second design change on 11 October 2017


The contract amount was NT\$78,544,238 after the change, and the completion date set at 26 November 2017 (construction period increased from 313 days to 365 days). The second design change took place because the 1/F office space required adjustment, the 2/F and 3/F required hallway ceilings and curtain box, power cables required an upgrade, the Counseling Room required adjustment on wooden renovation, and the air-conditioning project required adjustment.

IX. Project Difficulties and Solutions

- There was no original design drawing for the Project, which caused the differences between the initial design drawing and the actual construction.
- Solution: After requesting the technicians to perform on-site survey, the construction was adjusted in line with the existing status.

- The Project is a long and narrow type. There was only one entrance/exit for cleaning operations at the site, and the amount of debris was more than expected. The structure is fragile, cannot use machine to carry out indoor demolition, and there were unidentified military pipelines which affected the construction.
- Solution: On 23 February 2017, it was negotiated and agreed that the machine can access the camp on weekdays; on 28 February 2017, the military moves out from space of X1~X4; on 10 March 2017, consent was obtained to remove the coconut tree outside of F3 base location, and negotiated with the military to construct ramp at the F2 base location to facilitate the transportation of machines and materials; on 3 June 2017, it was negotiated and agreed to reallocate all pipelines.



X.Project Supervision Team and Supervision Records

The organizer held a pre-construction meeting with the contractors before the commencement, instrusting that, in order to complete on 25 December 2017 and smoothly hold Office 3 opening ceremony on 8 February 2018, there shall be personnel dispatched on daily basis to conduct on-site supervision (and take turns during holidays), the project supervision meeting shall be held on weekly (a total of 54 weekly supervision meetings) and monthly (a total of 12 monthly supervision meetings) basis until the completion, Prosecutor Investigator LIEN YANG who has civil engineering, structure, geotechnical qualification shall be assigned to assist the architect and Taiyi Construction in solving site affairs, and LINE group shall be utilized during the period to solve site issues promptly.

XI. Set-Up Process of Office 3 and Digital Evidence Collection Room

Taiwan Taipei District Prosecutors Office was established on 1 November 1945. Due to economic prosperity in its juridical area, there are many issues causing inconvenience in operation such as the increasing number of litigation cases accepted every year, the expanded staff quota, and the scattered office buildings. For a long-term fix, the Ministry of Justice had coordinated with the Ministry of National Defense to appropriate its current location, the Procurement Building of the Republic of China Armed Forces Reserve of Ministry of National Defense, to the Office, which was approved by the Ministry of National Defense

The said building has been in use since its completion in 1964. It has been half a century; the walls were chipping off and leaking, and the equipment were outdated; it was not in compliance with the requirements of the current Building Control Act and Fire Services Act and affected the structural safety of

the building. The leaders of all levels of the Ministry of Justice coordinated to raise funds for planning and updating, then, the Executive Yuan approved a renovation fund of NT\$81,931,652, where Prosecutor Investigator, Lien Yang, shall be the organizer, Chieh Chien-Hua architect firm shall be in charge of design and supervision, and Taiyi Construction Co., Ltd. shall be in charge of construction. Structural seismic reinforcement and renovation were carried out and scheduled to be completed in 2017. It was named "Taiwan Taipei District Court Prosecutors Office - Office 3".

In order to effectively combat crimes, the Office had independently developed a drug database funded by the technology project of the Ministry of Science and Technology in 2015. During the period, it was noticed that mobile communication applications (such as Line, WeChat, etc.) are gradually replacing the traditional telephone communication and becoming

the mainstream of communication. Thus, the fund was used to purchase one unit of digital evidence collector and assigned staff members to participate in the training, learning the techniques of capturing and restoring social media image records and other information on mobile devices and unlocking mobile phone passwords, etc., which was pioneer among procuratorates in the country.

Based on the above-mentioned foundation and in order for expand the use of the above-mentioned technology, the Office has intergreted expertise of the Office's Prosecutor Investigators by having the Prosecutors lead the establishment of Digital Evidence Collection Team to train digital evidence collection talents. A total of 13 Prosecutor Investigators who are eager to learn such skill were recruited and collected evidence from more than 150 mobile devices seized in various cases as directed by the Prosecutor; now, they can independently complete digital evidence collection tasks and trace for criminal clues quickly at any time.

On 11 May 2017, the Executive Yuan adopted the New Generation Anti-drug Strategy to face drug crimes and other related issues with more effective resource integration. As for the aforementioned current situation of drug crimes committed through means of communication applications, High Court Prosecutors Office had drawn up the "Digital Evidence Collection Operations Team Establishment Plan of Taiwan High Court Prosecutors Office and Its Subordinate Prosecutors Offices" in 2018 to purchase and distribute relevant hardware equipment for evidence collection, while instructing relevant District Prosecutors Offices to set up Digital Evidence Collection Room.

The Office integrated the digital evidence collection experiences, trained skillful Investigators and supervision of the Prosecutors in the establishment of the Digital Evidence Collection Center and the followings at the Office: (1) Discussion Room; (2) Evidence Collection Room (including evidence retention); (3) drug database. On 1 February 2018, the

evidence collection operation commenced its new stage upon the opening ceremony held by the minister. It is expected that the Evidence Collection Room can provide cases with evidence collection results even more quickly under the software, hardware and human resources, enrich the evidence collection database and combat various crimes more effectively.

XII. Opening Ceremony of Office 3 and Digital Evidence Collection Room

In consideration of the current procuratorate name is easily misunderstood as being subordinate to the court as well as being inconsistent with the principle of independent prosecution from trial, National Conference on Judicial Reform removed "Court" in front of each Prosecutors Office upon resolution, thus, on the morning of 8 February 2018, all procuratorates national-wide had their name plates changed simultaneously. The Office scheduled to hold the opening ceremony of name-plate update at 11:00 am, which will be personally hosted by Minister of Justice, Chiu Tai-San and witnessed by Secretary-General of Judicial Yuan, Lu Tai-Lang, Political Deputy Minister of Justice, Chen Ming-Tang, Political Deputy Minister of Justice, Tsai Pi-Chung, Administrative Deputy Minister of Justice, Chang Tou-Hui, Section Chief of Prosecution Section of the Ministry of Justice, Lin Pang-Liang, Section Chief of Comprehensive Planning Section of the Ministry of Justice, Lin Li-Ying, Prosecutor General of Supreme Prosecutors Office, Yen Ta-He, Chief Prosecutor of Taiwan High Court Prosecutors Office, Wang Tien-Sheng, President of Judges and Prosecutors Training Institute, Tsai Pi-Yu and Chief Judge of Taiwan Taipei District Court Huang Kuo-Chung. The ceremony was simple and grand.

The opening ceremony of Office 3 and Digital Evidence Collection Room was then held at 11:20 am with Ms. Iris Liu sang a "Blessing Song" in Chinese and English under the violin accompaniment of the Office's Substituted Civilian Serviceman, Lin Hsin-Tzu, to celebrate the completion of the office building. Ms. Iris Liu who sang the "Blessing Song" to bless "fresh new start of everlasting prosperity" is a talented young female singer and beloved daughter of the Office's Head Prosecutor, Liu Cheng-Wu; her grandfather used to be the Chief Secretary of the Office as well. A three-generation of relationship with Taiwan Taipei District Prosecutors Office, something Taiwan Taipei District Prosecutors Office is very proud of; and it added nice judicial story with her beautiful voices left in this historical event.

At the beginning of the ceremony, Minister Chiu, Prosecutor General Yen, Chief Prosecutor Wang successively delivered speeches and congratulations to encourage the inheritance of excellent traditional and continuation of hard work to meet people's expectations in procuratorate. Minister Chiu also presented tokens of appreciation to the director committee member of Taiwan Taiwan After-care Association Taipei Branch, Lin Ping-Yao ("Good Practice of Philanthropy") and creator of "Libra", Wu Tsung-Lin ("Art of Balance"). Director committee member, Lin Ping-Yao, and his team not only invested in after-care protection works, but also made many contributions in promoting social peace. In order to celebrate the completion of Office 3, the honorable attendants donated "Libra" to Taipei District Prosecutors Office. Mr. Wu Tsung-Lin, the national master of copper art is also kind enough to teach the art of bronze gongs in
